#### 1162 Chairman's Welcome

The Chairman welcomed everyone to the meeting.

#### 1163 Apologies for Absence

Apologies were received from Cllr. Robert Milton and Cllr. Peter Davies who both had a work commitments and Cllr. Martin Jones who was on holiday.

#### These apologies were ACCEPTED.

Cllr. Chris Woods was absent.

Apologies were also received from Shropshire Councillor Joyce Barrow.

#### 1164 Co-options

The Chairman invited Iain Campbell to give a short presentation on why he wanted to join the Council and represent the ward of Maesbury with Aston. He informed the meeting that he lived and worked in the ward in which he had a tourism business and was very much involved in local tourism.

The Chairman invited Mike Weston to give a short presentation on why he wanted to join the Council. He informed the meeting that, whilst he had only lived in Morda for 5 years, he had business experience which he thought could add value as a parish councillor.

After being put to the vote it was **PROPOSED**, **SECONDED** and **AGREED** that Iain Campbell be co-opted as a parish councillor.

After being put to the vote it was **PROPOSED**, **SECONDED** and **AGREED** that Mike Weston be co-opted as a parish councillor.

Both newly co-opted councillors signed their Declaration of Acceptance of Office.

#### 1165 Public Participation

\*One member of the public queried the accuracy of the minutes of the last meeting in comparison to what she had said during the public session and asked for them to be amended.

One member of the public expressed concern about the Terraces and its suitability for further development as the land was unstable. He asked the Council not to support any further development on that land.

One member of the public also expressed concern about the Terraces. He said this derelict land was dangerous as it was littered with building debris. He suggested it be used as open green space for community use and that trees should be planted.

#### 1173 Grant Awards

Members considered for approval grant requests received from Morda United FC and Qube. Members questioned how many people within the parish of Oswestry Rural were benefiting from the work of Qube. **It was PROPOSED, SECONDED and AGREED that:** 

- a) Grant awards would not be made at this time as further information was required.
- b) Qube should be asked what benefit its work had within the parish of Oswestry Rural and invited to attend a future Parish Council meeting to explain.
- c) A grant of up to £1,000 may be awarded to Morda United FC on production of the appropriate receipt.

#### 1174 Personnel Committee

Members considered for approval the appointment of one new member to the Personnel Committee. It was PROPOSED, SECONDED and AGREED that Clir. Jas Singh be appointed to the Personnel Committee.

#### 1175 Strategic Plan

Members considered for approval revisions to the Strategic Plan. It was PROPOSED, SECONDED and AGREED that the revisions to the Strategic Plan be APPROVED.

#### 1176 Allocation of Funds

Members considered for approval the allocation of funds as presented by the Clerk. It was PROPOSED, SECONDED and AGREED that allocated funds be APPROVED as presented by the Clerk.

#### 1177 Code of Conduct

Members considered for approval the adoption of a new Code of Conduct as revised by the Local Government Association.

#### It was PROPOSED, SECONDED and AGREED that:

#### 1178 Neighbourhood Watch

Cllr. Roger Jones asked Members to consider for approval the establishment of Neighbourhood Watch Schemes throughout the parish. Co-ordinators would need to be found and Cllr. Jones had volunteered to be a co-ordinator for Coed-Y-Go. There was no cost for the scheme itself although there may be costs for posters/publicity etc.

It was PROPOSED, SECONDED and AGREED to support the establishment of Neighbourhood Watch Schemes throughout the parish and co-ordinators should be sought.

#### 1179 Road Safety

a) At the last meeting a member of the public had asked the Parish Council to consider speeding issues at Morton.

It was PROPOSED, SECONDED and AGREED that the Road Safety Working Group would liaise with the concerned member of the public about this issue.

 b) Cllr. Les Maguire informed Members that speed counters had been installed at Coed-Y-Go, and that Cllr. Dean Carroll at Shropshire Council would be facilitating a meeting with local residents some time in November.

It was PROPOSED, SECONDED and AGREED that Cllr. Dean Carroll be thanked for the prompt action and asked that the traffic counter remained in situ until after half term.

#### 1180 Drainage

Cllr. Roger Jones reported that WSP had removed the big manhole and replaced it with 2 containment ponds to take away excess water. However, this would only deal with land issues and not operational issues, and he was concerned about where the wash containing the slurry from Trefarclawdd Farm would go. He was still waiting for a response from Shropshire Council concerning the drainage scheme at the farm and the impact of farming activities on the local community and the environment.

It was PROPOSED, SECONDED and AGREED that Shropshire Council should be asked to respond to Cllr. Jones' request for information concerning activities at Trefarclawdd Farm and, if a satisfactory response was not received, the matter should be referred to Cllr. Lesley Picton, the Leader of Shropshire Council.

#### 1181 The Terraces

Members considered residents' concerns about the suitability of further development at The Terraces, its planning history and access to the site. Cllr. Martin Bennett asked Members to consider that:

- Notwithstanding Planning Policies relating to the preferential development of brownfield sites, and the use of windfall sites to provide additional housing, the site at The Terraces, Morda, the subject of planning application OS/08/15863/REM, should not be used for housing, due to the uncertainty of the underlying geological conditions created by historic mining.
- In accordance with the Council's Strategic Plan, Theme 6.17 (Promote tourism and celebrate local heritage) the site given the potential difficulties of development for housing, would be better used to create an area where the mining history and heritage of the Morda Valley could be adequately explored, and/or community uses developed (Strategic Plan, Theme 3.10).

Cllr. Bennet further asked the Council to NOTE:

- In addition to the geological issues there was also a potential legal bar to development relating to the potential claim by residents for adverse possession of the existing right of way, which if proved, would prevent access by a developer.
- Several breaches of planning conditions may have occurred in relation to undertaking given by agents for the applicant in respect of fencing, protection for trees on the site and items of archaeological interest and value.

Cllr. Bennett PROPOSED, and it was SECONDED and AGREED that:

- a) Shropshire Council should be asked to clarify if they consider that the extant planning permission had in fact been implemented.
- b) Shropshire Council should be asked to investigate alleged breaches of planning conditions as a matter of urgency as they relate to any assumed planning permission.
- c) The Parish Council would explore the option of funding a search of the Land Registry through Lanyon Bowdler to try to determine if the land had been registered, and that the costs and feasibility of funding a claim for adverse possession on behalf of the residents, which actions would further the Parish Council's aims in respect of the Strategic Plan Themes 6 and 3, and the Parish Council's view expressed to Shropshire Council that the parish area of Oswestry Rural should be considered as 'Countryside'.

- d) The Clerk be given a budget of £1,000 and granted delegated authority to instruct Lanyon Bowdler to carry out the necessary searches.
- e) The matter would be considered further at the next meeting.

Cllr. Les Maguire abstained from the vote.

#### 1182 Development Issues

As Cllr. Peter Davies was not present it was AGREED to defer this matter to the next meeting.

#### 1183 Allotments

Cllr. Steve Watts informed Members that he had been approached by a local resident enquiring about the provision of allotments as there was presently no provision. He asked Members to consider the demand, if any, for the Parish Council to provide allotments, in pursuance of the Small Holdings and Allotments Act 1908 s23.

It was PROPOSED, SECONDED and AGREED to determine the demand, if any, for the provision of allotments within the parish.

#### 1184 Notice Boards

Cllr. Steve Watts expressed concern about the state of the notice boards within the parish. The Clerk informed Members that the notice boards had recently been re-varnished. However, Members expressed concern that the notice board at Morda shop had not been included. Cllr. Watts also asked who was responsible for updating the notice boards and the Clerk explained that several councillors and members of the public kindly volunteered to post the various Parish Council notices although more volunteers were needed.

## It was PROPOSED, SECONDED and AGREED that the following councillors would be responsible for posting notices:

#### 1187 Remembrance

Members considered for approval arrangements for Remembrance Sunday on 14 November 2021. The Clerk informed Members that a road closure had been granted.

It was PROPOSED, SECONDED and AGREED that:

- b) 40 small crosses should be purchased.
- c) Clirs. Bob Kimber and John Davies would make arrangements for the road closure and the service.

To note:

• The Clerk has asked SALC if it intends to assist parish councils with responding to the <u>Consultation on Amendments to the Environmental Permitting (England and Wales)</u> <u>Regulations 2016 as applied to Groundwater Activities and related Surface Water Discharge Activities</u>. Here is the response so far:

"Shropshire Council are considering bringing in an expert who might be able to identify the geology beneath your cemeteries and where source protection zones are etc. They say the proposals would adversely impact upon all councils both in terms of longevity of cemetery space and in terms of income that can be generated from each site. Further discussion on the likely practical impacts, e.g. what would happen to graves pre purchased with instructions in place that might then be compromised would follow and then we can consider collectively sign up to a Shropshire response or submit individually but a Shropshire Council response is anticipated. We have not heard from TWC. Also, NALC at this stage have said they will be involving us in discussion with their Policy Committee and we will expect them to issue a consultation document.

Jonathan at Hadley & Leegomery attended a webinar arranged by the Institute of Cemetery & Crematorium Management on 28<sup>th</sup> October, where there was further clarification of the exemption criteria which will be determined by (1) the number of burials annually at a given cemetery and (2) the level of risk the cemetery's geology and /or location within a groundwater protection zone. Various questions were raised and while the responses were encouraging, there is still a lot to be thrashed out."

- The owner of the land at Sweeney where a new notice board is to be installed has agreed to a binding agreement for the council to access it when necessary and that it remains the property of the Parish Council.
- The Clerk has made enquiries with West Mercia Energy about the cost of streetlight electricity in comparison to the current charge with the Parish Council's supplier SSE. After comparing the costs, it is cheaper to continue with the supply from SSE.
